1. INTRODUCTION

1.1. VIVEKANANDA ROCK MEMORIAL & VIVEKANANDA KENDRA

An aggregate or a congregation of men does not make a nation, nor does the geographical area and duration of time qualify a society to be known as a nation. A government formed on such a basis can be called a state, but not a nation. It is common goal or mission that makes a nation. All the constituents strive collectively for something noble. Service with spiritual orientation results in manmaking which invariably and inseparably connected with nation building.

The Vivekananda Rock Memorial was dedicated to the nation in September, 1970 at the historic rock off Kanyakumari where Swami Vivekananda discovered his mission. Vivekananda Kendra - An extraordinary organization of ordinary men and women - was founded in 1972 as a living memorial to work out Swami Vivekananda's vision and mission by Mananeeya Sri Eknathji Ranade, the visionary behind the Memorial. A Spiritually oriented Service Mission, the Kendra serves as a living memorial to Swami Vivekananda, comprising a cadre of dedicated Jeevanvratis, Sevavratis, Vanaprasthis, along with thousands of local Karyakartas, patrons, subsribers and well-wishers .. With Man-Making- Nation Building as its twin objectives guided by the national ideals of Renunciation and Service, the Kendra is centred around the noble thought that "Service to humanity is worship of God".

1.2. VIVEKANANDA KENDRA - ORGANISATIONAL OUTREACH

Today the Vivekananda Kendra has over 1,332 branch centres and activity centres where full-time karyakartas (Jeevanvratis) and local karyakartas carry out various service activities through Yoga Varga, Swadhyaya Varga (Study Circle), Sanskar Varga (Cultural classes), Kendra Varga (for nurturing karyakartas). The Kendra also has projects in various fields spread across India.

1.3. VIVEKANANDA KENDRA VIDYALAYAS

Education is not the amount of information that is put into your brain and runs riot there, undigested all your life. We must have life-building, man-making, character-making, assimilation of ideas. - Swami Vivekananda

Vivekananda Kendra runs formal schools in Arunachal Pradesh, Assam, Nagaland, Maharashtra, Tamilnadu and Karnataka. Apart from this the Kendra imparts informal education through Aananadalaya - the Kendra's school-supportive initiative to stem drop out rate for children in tea garden, remote villages as well as slum areas of cities. Balwadi is another form of informal education that caters to pre-primary children in rural areas.

At present there are 84 Vivekananda Kendra Vidyalayas (VKVs). 40 VKVs , 2 Ekalavya Model Residential School (EMRS) and 2 Kasturba Gandhi Balika Vidyalayas in Arunachal Pradesh. 25 VKVs in Assam, 1 VKV in Nagaland, 11 VKVs in Andaman & Nicobar Islands, 2 VKVs in Tamilnadu and 1 VKV in Karnataka. Approximately 32,000 students study in these premier institutions.

1.5. VIVEKANANDA KENDRA VIDYALAYAS ARUNACHAL PRADESH TRUST

History of VKV AP Trust

The genesis was humble. In response to the invitation of the then Lt Governor of Arunachal Pradesh, Sri K.A.A Raja, 7 VKVs were established in the year 1977 by Mananeeya Eknathji Ranade. Since then, VKVs have been imparting holistic education. As the years rolled by more VKVs were established to cater to the needs of the state. Rendering service in the remotest of areas, the VKVs have carved a niche as premier educational institutions imparting quality education in the land of the rising sun. From a nascent beginning, it has now become a vibrant colossal institution. Today VKVAPT runs one college of teacher education, 44 (Forty four) Vidyalayas (including 2 Ekalavya Model Residential Schools), VKVAPT supports 2 Kasturba Gandhi Balika Vidyalayas managed VK Arun Jyoti and Gurukuls run by Donyipolo Cultural and Charitable Trust by deputing qualified teachers of CBSE related subjects.



A large number of first generation students now serve Arunachal Pradesh and different parts of the country in varied fields such as administration, agriculture, art, bureaucracy, business, design, education, engineering, fine arts, law, medicine, military, music, policing, politics, etc.

The course aims to equip the students with the following:



2. GENERAL INFORMATION

2.1 THE COLLEGE LIBRARY

The college has a well-equipped library to facilitate the teaching-learning process with a collection of over 3,000 books apart from various journals, etc.







2.2 ICT LABORATORY

The college has a well-equipped Information and Communications Technology (ICT) room with a collection of 20 computers, 1 Smart Board, Internet, LCD Projector, and other related aids.



2.3 PSYCHOLOGY LABORATORY

The College has a well-equipped psychology cell equipped with psychological kits, books and all other necessary instrumental aids.

2.4 SCIENCE LABORATORY

The well-equipped science lab has three separate wings for Physics, Chemistry and Biology to give a wide experimental experience.

2.5 GEOGRAPHY LABORATORY

The Geography lab is equipped with basic study tools and necessary material sufficient to give firsthand experience.

2.6 PHYSICAL EDUCATION BRANCH

The Physical Education branch was setup in the year 2015 to conduct programs and activities for all round development of the students' personality. The branch conducts sports, cultural activities and youth affairs activities.

2.7 CANTEEN

The College has a well-equipped and hygienic canteen.

2.8 STIPEND/SCHOLARSHIP FACILITY

The college grants stipend/ scholarship facilities to those students from the APST category who have secured minimum 75% attendance in regular classes. It is provided and sanctioned by the Department of Technical and Higher Education, Government of Arunachal Pradesh, Itanagar.

3. OTHER FACILITIES

3.1 COUNSELING AND RESOURCE ROOM

Personal Counselling is an integral part of the College. Personal Counselling is offered by a designated faculty who also serves as Student-Advisor'.

Career Counselling is also provided by the college. The students will be exposed to various career options — academic or otherwise. Students are helped with lectures and short-term courses to groom them for interviews, group discussions, etc.

Resource Room — Psychology, Pedagogy, Teaching-Learning Centre:

A special provision of Resource Centre for student-teachers (OJT- Internship) has been made in the academic block and relevant materials, research manuals and case-studies are available.

3.2 EXTRA-CURRICULAR AND CO-CURRICULAR ACTIVITIES

The College provides an array of co-curricular activities viz. Yoga, debating, quiz contests, gardening, creative writing, graphic design, creative drama, 'theme based' assemblies', public speaking, group discussions, Film review, book reviews and so on.

3.3 INTERNAL ASSESSMENT

Under the semester system, students will have periodic internal assessment tests. These tests are compulsory for all students.

4. COLLEGE RULES AND REGULATIONS

4.1 CODE OF CONDUCT BY STUDENTS


Any act of misconduct committed by student inside or outside the college campus will be an act of violation of discipline of college. It includes,





- The students should conduct themselves in an exemplary manner so as to be a model for other students and also for a school Students.
- All the students will have to adhere to the rules and regulations of the College and the affiliated University.
- Disruption of teaching, study, examinations, administrative work, scholastic and nonscholastic programs or residential life of teachers or any other member of college.
- 4. Use of abusive words, offensive language or incitement of violence.
- Disrespectful behaviour towards peers, men and women, faculty members or any other member of the college or those in the campus.
- Damaging or defacing college property or property of any other faculty member of the college or that of VKV property or any property inside or outside the college campus.
- Committing forgery, tampering with or misuse of college documents, records, identity card, etc.
- Smoking and using and / or possessing alcohol and / or illicit, dangerous drugs, chewing pan, tobacco etc inside or outside the college campus is not allowed.
- 9. Possessing or carrying or using any weapon inside college is not allowed.
- Any other act, which may be considered by management, principal or any other member of college as violation of discipline.
- 11. Physical restraint, assault, or any other act of violence or use of physical force against any member of the college or any act that threatens the use of physical force is strictly prohibited.
- 12. Bullying includes any electronic, written, verbal, or physical act or a series of acts of physical, social, or emotional domination that is intended to cause, or any reasonable person should know would cause, physical or substantial emotional harm to another student or member of college.
- Excessive noise, which interferes with classes, College offices, residence hall, neighbours, or others in the campus.
- 14. Unauthorized entry into or occupation of a private work area.





- 17. Failure to disperse when a building, office, or campus space is closed.
- 18. Other conduct that disrupts the operations of the College, such as lectures, meetings, events (such as admissions tours or job interviews), ceremonies, or other necessary business and community functions.
- 19. Notwithstanding the specific rules which are explicit, the Principal or his/her nominee has the residuary power and can act in situations where such explicit rules are not provided for.
- 20. The students who do not adhere to the rules or whose behaviour adversely affects the reputation of the college may be expelled by the Principal or may be punished depending on the nature and degree of offence or breach of rules in consultation with the Disciplinary Committee of the institute. However, the Principal's decision is final in all matters of punishment.
- 21. Use of mobile phones and electronic gadgets are not permitted in the classrooms, examination hall, functions, programme and co-curricular activities.

4.2 GENERAL DISCIPLINE

- Students should take their seats before the faculty enters the class room and not ordinarily leave the class without due permission from the faculty present in the class during exigencies.
- · Students should use the library during their leisure hours instead of loitering here and there.
- Students at all places inside the college and outside whether at playfield or in any meeting and function, should conduct themselves with a sense of decency and decorum.
- Students without any business should not disturb the office staff on any account.







4.3 ATTENDANCE

Students must attend minimum 80% of the theory and practical classes, and 90% for internal assessment. Students who fail to attend their classes over certain period of time, only on reasonable and acceptable grounds (serious illness, accidents or treatments, or death of near and dear ones etc.) must apply for the consideration or exemption of the absence.

4.4. DRESS CODE

For all the students it is mandatory to wear uniform as per the specification given below:

All working days except Wednesday and Saturday:

Male Students: Formal Navy Blue Trousers and White Shirt, Black formal shoes, and short hair.

Female students: Navy Blue Saree with white blouse or same color traditional common Arunachali dress (Gaale) with white Top with Black formal shoe, and neatly tied hair.

On Wednesday and Saturday: Students need to wear formal dress that largely covers them like Sarees/Churidar/salwar-kameez with dupatta for women students and formal trousers & Shirt for men students. On national holidays all students must be in full uniform.

4.5 LEAVE RULES

Since it is a professional degree college, the students are discouraged to avail themselves of leave of any kind. However, in exceptional cases one may be granted leave up to maximum of ten days during an academic session. Such leave not exceeding six days may be granted at a time.

Disobedience of these rules shall be seriously viewed and drastic disciplinary action to the extent of expulsion from the college shall be taken against the defaulters. Hence students are advised to observe these strictly.

Note:

Leave cannot be claimed as a matter of right and the grant of leave depends upon the discretion of the Principal.

Application for leave on flimsy grounds shall be rejected without assigning any reason thereto. Interpretation of the aforesaid rules rests entirely with the Principal.

4.6 PROHIBITION OF RAGGING

Students are advised to refrain from any indulgence of ragging of fellow students/ others.

Ragging is no act of Bravery.

Ragging is a blot to humanity and causes irreparable damage and untold harm.

An Anti-Ragging Committee / Disciplinary Committee is constituted to monitor ragging incidents.

Students in distress should not hesitate to approach the Committee and should immediately report without fear to the Disciplinary Committee.

Ragging is considered as a cognizable offence under the law. Ragging in all its forms is totally banned in the entire institution, including its departments, constituent units, all its premises (academic, residential, sports, canteen, etc.) and outside and could be penalized under the Court of Law as an offence of wrongful restraint under Section 339 of the IPC which is punished with simple imprisonment up to 1 month, or with fine up to Rs 500/- or with both.



4.7 RUSTICATION AND EXPULSION OF STUDENTS

- 1. The Principal of the College shall have the power to expel or rusticate a student for sufficient reasons including acts of indiscipline and misconduct inside or outside the College.
- 2. Before rusticating or expelling a student an enquiry shall be held and adequate and reasonable opportunity shall be given to the student concerned to explain his/her position and a complete record of the case shall be maintained.





- Each case of order of rustication or expulsion shall be reported to the Secretary, VKVAPT, Governing Body by the Principal without delay after the order has been passed by him/her and it shall be accompanied by a certificate signed by the Principal to the effect that the student had been given adequate and reasonable opportunity to explain his/her position before the order is passed. Further the student will be given adequate and reasonable opportunity to explain his/her position to the Secretary, VKVAPT and/or Governing Body before the order is finally passed. If the Secretary, VKVAPT and/or Governing Body, VKCTE are convinced by the student, the Secretary and/or Governing Body may ask Principal to reconsider his/her order. Or Principal may be asked to continue the course of action.
- 4. The Principal may, for reasons to be recorded, review and amend his/her order within ten days of the original order. The amended order so passed along with reasons shall be reported without delay to the Secretary, VKVAPT and/or governing body.
- As soon as rustication or expulsion of a student has been notified by the Secretary, VKVAPT, his/her name shall be removed from the rolls of the College. He/her shall not pay any fees to the College during the period of rustication or expulsion.
- 6. Rustication shall mean loss of one academic year i.e. the student concerned shall not be allowed to appear in any University examination during the academic year in which he/she is rusticated, and his/her name will be removed from the rolls of the College from the date the Principal passes the orders of rustication. A rusticated student may rejoin the same class in the same college with the permission of the Principal concerned during the days of admission in the following academic year or subsequently within the period permitted otherwise.
- A student who is expelled from a College shall not be readmitted in the College without the prior sanction of the Secretary, VKVAPT. An expelled student shall not be allowed to appear in any University examination during the academic year in which he/she is expelled and the following year and his name shall be removed from the rolls of the College from the date the Principal passes the order of expulsion.
- If the Secretary, VKVAPT is of the view before or after notification that the order of a Principal rusticating or expelling a student requires revision in the light of new facts which come to his/her knowledge, the Secretary, VKVAPT may bring the matter to the notice of the Governing Body, whose decision shall be final.

9. In case of indiscipline created by a student of another College, the Principal shall have the right to bring the facts to the notice of the Principal of the College to which the student belongs and also to the notice of the Secretary, VKVAPT. The Secretary, VKVAPT may take cognizance of the fact for appropriate action in the matter including expulsion/ rustication on the basis of the report of the duly constituted Enquiry Committee.

All students before enrolling themselves and before paying fees shall require to give an undertaking in the prescribed format to the Principal, VKCTE. Violation of the undertaking at any point of time, results in expulsion from the college and no refund of any fees/deposits etc.

Note:

The Principal with due approval of Core Committee of VKVAPT/ Governing Body reserves the right to alter, add or delete these rules at any time. Violation of these would warrant disciplinary action.

ELIGIBILITY

- (a) Candidate with M.A./ M.Sc./ M.Com./ B.A./ B.Sc./ B.Com./ (B.E./ B.Tech. with specialization in Science and Mathematics having 55% marks), degree (10+2+3 scheme) from Rajiv Gandhi University or any other recognized university with 50% marks in graduation and qualified in RGUCET 2025 is eligible for admission into B.Ed. (General) Course.
- (b) SC, ST and OBC (NCL) candidates shall be given relaxation of 5% marks. NCL candidates should produce NCL certificates issued for the current year.
- (c) Candidates who have appeared in qualifying (Bachelor Degree) Examination can also apply. However, such candidates will have to submit proof of having passed the qualifying examination at the time of admission.

NOTE:

- One-time Security Deposit Rs. 5,000/- (Refundable) will be collected during the time of Admission in the first Semester.
- Charges towards Field Trip, charges towards monitoring by faculty of internship and practice teaching, etc. will be collected from students as per average expenditure
- Examination fee will be collected separately during the time of Examination as per information from RGU





- Fees once paid will not be transferred to any other student/course/program.
 Security deposit will be returned on completion of course within 6 (six) months
 (after reopening of college, against written application and on production of
 original fee receipt.)
- Fees to be paid in advance before re-opening/commencement of every Semester.Student is allowed to attend the class only after fees is paid.
- Fees amount to be paid through VKCTE's Shiksha Software (Online banking) in the name of the A/C of "Vivekananda Kendra College of Teacher Education."
- 4. A late fee of Rs. 500/- per day will be charged for delayed payment of admission fees beyond 2 days (please refer to the academic calendar for the college reopening date), up to 15 days. After this period, the candidature will be cancelled. It is the responsibility of the student/parent to adhere to the fee payment schedule. No separate reminders will be issued.

7.2 REGISTRATION FEE (ANNUAL)

Registration will be separate for those students who have completed their graduation/ qualifying degree from any other university apart from the affiliating university i.e. Rajiv Gandhi University. The process will be notified by the college authority.

Other General Fees or Charges (As & when Applicable)

RULES FOR SECURITY DEPOSIT MONEY BY STUDENTS

All the students seeking admission to VKCTE shall pay security deposit of Rs.5,000/-. This is to cover the risk of damage to library books, laboratory equipment and ensure good conduct from students.





GUIDELINES FOR REFUND OF SECURITY DEPOSIT BY E-PAYMENT SYSTEM

- All relevant details of bank account in which refund is to be processed is to be given by the student in the applicable prescribed format to be downloaded from the VKCTE website.
- 2. Hard copies will not be provided to the students.
- 3. Prescribed format is to be filled only in capital letters.
- 4. There is no fee for the prescribed format for E-payment of Security deposit.
- 5. Final Year Students just after the declaration of final year results can submit security deposit claim Form in duplicate downloaded from the college website and submit within 90 (Ninety) days from the date of result declaration. Security deposit may be claimed only between the periods from July to September each year. Those who fail to submit the application within prescribed date students have to submit the application next year. The deposit return claim can be made within three years after final result declaration.
- The form needs to be complete in all respects. Any incomplete form / missing information will not be accepted by the Office and no refunds will be processed.
- 7. Students are advised in their own interests that they should take due caution and care while filling up the form. This is because if any of the details are filled incorrect, student will not receive the security deposit and for which student will be solely responsible.
- Students should give details of their own active account into which they want refund to be credited.
- If the details mentioned by student in the prescribed format are incorrect due to any reasons (including typing / writing error, etc) the student shall be completely responsible for any loss such as non-receipt of security deposit.
- 10. The student himself/herself shall be responsible for communicating any changes in prescribed format if such changes occur after submitting the form and the student fails to inform, it will be the sole responsibility of the student and the student will not receive any security deposit.

- 11. The College will not be responsible for wrong credit of security deposit in case where student has mentioned incorrect account number and other details in the prescribed format. In such cases, the student will not be getting any security deposit.
- 12. All charges related to transfer of E-payment (as may be applicable and levied from time to time by the bank) will be borne by the student.
- 13. All information which is required at the time of applying for security deposit such as final mark sheet, original fee receipts, written application, admission number and the date of leaving the college and "No dues Certificates" from the Librarian, the Laboratory In charge and Accounts section, etc.
- 14. The Accounts section will verify the details, the same will be put before the Principal for its sanction. The Security Deposit amount will be refunded through Account Payee Cheque only.
- 15. Any unclaimed Security Deposit shall lapse if it remains for two semesters, succeeding the end of the semester in which students left the college.

7.3 FEE REFUND

If a student chooses to withdraw from the program of study the institution shall follow the following Three-tier system for the refund of fees remitted by the student.

7.4 SALIENT FEATURES OF THE CHOICE BASED CREDIT SYSTEM REGULATIONS

(As per the Clause 42, of the Rajiv Gandhi University Act, 2006, No. 8 of 2007)

The Regulations on Choice Based Credit System (CBCS) shall apply to all postgraduate degree, diploma and certificate programs awarded and conferred under the Rajiv



Gandhi University, Rono Hills, Doimukh. However, admission, attendance, academic calendar, semesters, academic program, internal assessment and any other matter which are not covered under these Regulations shall be as per the existing Ordinances and Regulations on Semester System.

COURSE

- Usually a course refers to 'paper and is a component of an academic program.
 Our college is having B.Ed. Two Year Program only.
- There shall be a minimum of 18 credits per semester and shall be a maximum of 4 modules in a course of theoretical nature.

A. CREDIT ALLOTMENT

- Credit Point indicates that it is the product of grade point and number of credits for a course.
- ii. The credit refers to weightage given to a course. Each course/ paper for the academic program shall be measured in terms of credit where one credit is equivalent to one hour of teaching (lecture or tutorial) or two hours of practical work/ field work per week for one semester. There shall be a maximum of 4 credits for each course/ paper of theoretical nature.
- iii. Each theoretical paper offered by the institution carries 4 credits uniformly, while each practical paper carries 2 credits. This structure totals 18 credits for the first three semesters and 20 credits for the fourth semester, which is a total of 74 credits for the entire B.Ed Course.

B. GRADE POINT

It is a numerical weight allotted to each letter grade on a 10-point scale. Each degree program shall have a minimum specified credit requirement. The minimum credit requirement shall also be specified separately for different categories of courses, i.e., core courses, Departments/ Centre/ Institute.

C. SEMESTER GRADE POINT AVERAGE

It is a measure of performance of work done in a semester. It is ratio of total credit points secured by a student in various courses registered in a semester and the total course credits taken during that semester shall be expressed up to two decimal places.


i. The Semester Grade Point Average (SGPA) is the ratio of sum of the product of the number of credits with the grade points scored by a student in all courses and sum of the number of credits of all courses undertaken by a student shall be calculated in following manner.

ii. SGPA(Si)=(Ci X Gi)/ Ci

Where C; is the number of credits of the ith course and Gi is the grade point scored by the student in the ith course.

Cancellation of Admission/Examination: The University may cancel the admission/ examination of a candidate if it is found that he/she is not eligible for admission/ or for appearing in the examination or has obtained admission through mis-representation or by concealment of facts.

Medium of Instruction and Examination: The medium of instruction and examination shall be in English only. However, in the language and literature course, medium of instruction shall be in the respective language.
